KAPOK STORE FIRE

TWO ENGINES CALLED OUT

FURTHER OUTBREAKS

Two further engines were called out to deal with a fire in a kapoc store in New Plymouth on Saturday night. The fire was undetected until the flames burst through the walls and roof of the building. Further outbreaks occurred in the kapoc yesterday morning, last night and in the early hours of this morning.

The New Plymouth Fire Brigade soon had the flames under control, but two men stayed on duty at the store for the rest of Saturday night and one stayed all yesterday and last night on account of the treacherous nature of kapoc where fire is concerned. Flames broke out in the kapoc yesterday morning and last night and four times in the early hours of this morning, but were easily quelled.

The building in which the fire occurred was erected many years ago and was attached to the two-storey workshop at the rear of the Devon Street frontage of Pursers Ltd. As it is surrounded by taller buildings the fire was not observed until two of the small rooms into which the store is divided were gutted. The alarm being given by a resident of the Grand Vue Boarding House in Gill Street at 10.14 p.m.

Two machines were sent from the fire station and although the flames had a good hold the brigadesmen used leads from plugs in both Devon Street and Gill Streets and gained control in quick time.

Nothing is known of the cause of the fire as no-one had been in the building since the morning. No other buildings were damaged but two rooms of the store were destroyed and the large quantity of kapoc stored was damaged by smoke and water.

PERSISTENT KAPOC

FIRE AT NEW PLYMOUTH

BRIGADESMEN ON GUARD

Fire undetected until it burst through the walls and roof of a building used as a kapoc store at the rear of the furniture premises of Purser's Ltd. in Devon Street, New Plymouth, was responsible for the calling out of both fire engines on Saturday night. Although the outbreak was soon under control two firemen remained on duty all Saturday and one throughout yesterday and last night.

Further outbreaks in the kapoc stored in the building occurred yesterday morning and last night but they were easily quelled.

The building in which the fire occurred (This house was the home of Mr & Mrs T.G. Sole, when married) was erected many years ago and was attached to the two-storey workshop at the rear of the Devon Street frontage of Purser's Ltd. As it is surrounded by taller buildings the fire was not observed until two of the small rooms into which the store is divided were gutted, the alarm being given by a resident of the Grand Vue boardinghouse in Gill Street at 10.14 p.m.

Both machines were despatched from the fire station and although the flames had a good hold the employment of leads from plugs in both Devon Street and Gill Street enabled the brigade to gain control in quick time.

Men were left on guard all night because of the treacherous nature of kapoc where fire is concerned and a further outbreak
had to be quenched yesterday morning. After a lapse of seven
hours, in which the lone brigadesman on duty saw no sign of fire,
flames again burst out.

Nothing is known of the cause of the fire as no-one had been in the building since the morning. No other buildings were damaged and although two rooms of the store were destroyed the premises were old and the financial loss was therefor comparatively slight. The large quantity of kapoc stored, however, was damaged by smoke and water.
